ELIGIBILITY CRITERIA

- 1. Business Eligibility:** The applicant must operate, own, or be a partner in a business that has been actively trading for at least 3 years.
- 2. Salary Requirement:** The applicant must be paid a minimum salary of approximately £50,000 in the UK.
- 3. Job Role:** The applicant must hold a senior or specialist role within the business, such as a manager, director, or expert in a specific field.
- 4. UK Business Presence:** The business must have a UK presence, such as a registered branch or subsidiary.
- 5. Genuine Business:** The business must be genuine and trading, with a clear intention to expand into the UK.
- 6. Maintenance Funds:** The applicant must have sufficient maintenance funds to support themselves in the UK.
- 7. English Language:** The applicant must demonstrate a good understanding of the English language.



PROCESS

Stage 1 Company Setup

Establish a UK company owned by your existing business.

Stage 2 Immigration License

Obtain an Immigration License for your UK company, authorizing it to sponsor overseas workers.

Stage 3 Certificate of Sponsorship

Secure a Certificate of Sponsorship for yourself, issued by your UK company.

Stage 4 Visa Application

Apply for the UK Expansion Worker Visa and, if applicable, for dependent family members.

Stage 5 Business Operations

Establish essential business operations in the UK within 2 years of arriving in the country.

Long-Term Residency and Citizenship

Visa Extension

After 2 years, apply for a 5-year visa extension.

Permanent Residency

After 5 years of residency, apply for Permanent Residency (PR) in the UK.

UK Passport

One year after obtaining PR, apply for your UK passport.
